**A RESOLUTION OF THE BOARD OF SUPERVISORS OF WEST PENNSBORO  
TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, ESTABLISHING FEES TO  
REINSTATE TRASH SERVICE**

**WHEREAS**, Section 1506 of the Act of May 1, 1933 (P.L. 103, No. 69), known as the Second Class Township Code, reenacted and amended November 9, 1995 (P.L., 350, No. 60), authorizes the Township to adopt any Ordinance, rule, or regulation necessary for the care and control of the township and its finances; and

**WHEREAS**, Article IV of Ordinance No. 2012-02 (Said Ordinance relating to collection, storage and disposal of garbage, recyclables and bulk items) authorizes the Township to, by Resolution, enact provisions necessary for administration of the Ordinance, including but not limited to fees and costs.

**WHEREAS**, the Board of Supervisors incurs an expense to collect and then redistribute trash totes and recycle bins.

**NOW, THEREFORE, BE IT RESOLVED, AND IT HEREBY IS RESOLVED**, by the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania, as follows:

1. Resident shall pay the sum of TWENTY-FIVE DOLLARS (\$25.00) to reinstate service to a trash account that was terminated for non-payment.
2. Any Resolutions or Ordinances inconsistent herewith are hereby repealed.
