A RESOLUTION FOR ADOPTING FEES FOR THE COLLECTION, STORAGE AND DISPOSAL OF GARBAGE, RECYCLABLES AND BULK ITEMS FOR RESIDENTIAL PROPERTIES PURSUANT TO WEST PENNSBORO TOWNSHIP ORDINANCE #2012-02

WHEREAS, West Pennsboro Township has adopted Ordinance #2012-02, enacted April 23, 2012, with an effective date of July 1, 2012, regulating the collection, storage and disposal of garbage, recyclables and bulk items for residential properties; providing for the authorization of a Township Collector for garbage, recyclables and bulk items; and providing for penalties for violation of Ordinance #2012-02.

WHEREAS, the Board of Supervisors of West Pennsboro Township wish to adopt and insert a current fee schedule for trash collection fees and will be set forth in the 2012 Fee Schedule adopted by the West Pennsboro Township Board of Supervisors.

NOW THEREFORE, be it resolved by the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania that fees listed on "Exhibit A" that is attached to this Resolution, shall be applicable for all residential trash removal, recycling and bulk item removal.



Full Service (90 Gallon Tote and Recycling Bin)	\$46.47
Senior Citizen Discount (65 Years or Older)	\$42.00
Individual 33 Gallon Trash Bags (Bags must be purchased from West Pennsboro Township)	\$3.50 per bag

FEES ARE BASED PER QUARTER

(Service will include weekly recycling and one bulk item per week)
