ORDINANCE NO. 2022 -02

**AN ORDINANCE OF WEST PENNSBORO TOWNSHIP, CUMBERLAND
COUNTY, PENNSYLVANIA, ESTABLISHING FEES FOR TAX
CERTIFICATIONS AND PHOTOCOPIES PERTAINING TO ACTIVITIES
OF THE TAX COLLECTOR'S OFFICE**

WHEREAS, the Tax Collector of West Pennsboro Township is required to provide tax certifications and to make photocopies pertaining to the functions and duties of the Office of the Tax Collector; and

WHEREAS, costs pertaining to these services have risen in recent years; and

WHEREAS, the Board of Supervisors desires to authorize new fees for the services noted above.

NOW, THEREFORE, be it enacted and duly ordained by the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania, and it is hereby enacted and ordained as follows:

SECTION 1:

Changes in fees for the Tax Collector may hereafter be set by Resolution of the Board of Supervisors from time-to-time as needed. The current fees made effective by this Ordinance are as follows:

- A. Tax Certifications. The charge for tax certifications is hereby enacted at the rate of Fifteen Dollars (\$15) each.
- B. Duplicate Bill Fee. The charge for duplicate bill fee is hereby enacted at the rate of Four Dollars (\$4) per copy.
- C. Non-sufficient Fund Fee. The charge for insufficient, returned checks is hereby enacted at the rate of Twenty-five Dollars (\$25) per check.

SECTION 2: SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the West Pennsboro Township Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 3: REPEALER. All prior ordinances that are inconsistent herewith are hereby repealed to the extent of such inconsistency.


SECTION 4: EFFECTIVE DATE. This Ordinance shall become effective immediately.
