

RESOLUTION NO. 2015-11

A RESOLUTION OF THE BOARD OF SUPERVISORS OF WEST PENNSBORO TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, ADOPTING THE BUDGETS FOR THE WEST PENNSBORO TOWNSHIP GENERAL FUND, THE WEST PENNSBORO TOWNSHIP LIQUID FUELS FUND, AND THE WEST PENNSBORO TOWNSHIP MUNICIPAL AUTHORITY 2016 ANNUAL BUDGET, AND ESTABLISHING THE MILLAGE RATE FOR TAXES TO BE LEVIED UPON REAL PROPERTY IN SAID TOWNSHIP FOR THE YEAR 2016

WHEREAS, the millage rate for taxes to be levied upon real property in said Township for the year 2016.

WHEREAS, The Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania, has duly advertised the proposed budget for the said Township for the year 2016.

WHEREAS, The Board of Supervisors has levied a tax on real property owned within said Township in accordance with the provisions of the Local Tax Enabling Law, the Second Class Township Code, and the Assessment Law of the Commonwealth of Pennsylvania.

NOW THEREFORE, BE IT RESOLVED, AND IT IS HEREBY RESOLVED, by the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania as allowed.

1. The Budgets for the calendar year 2016 as previously advertised and modified are hereby adopted as the official budgets for the year 2016.
2. The tax levied upon all real property within West Pennsboro Township shall be set at .2576 Mills, which equates to \$25.76 tax on a property assessed at \$100,000.00
