A RESOLUTION FOR ADOPTING LICENSING AND APPLICATION FEES PURSUANT TO WEST PENNSBORO TOWNSHIP ORDINANCE #2010-04, ALSO KNOWN AS AN ORDINANCE ESTABLISHING THE AUTHORIZATION, APPLICATION PROCEDURE AND OVERSIGHT OF SOLICITATION ACTIVITIES FOR TRANSIENT RETAIL BUSINESS ACTIVITY (ALSO KNOWN AS PEDDLING) WITHIN WEST PENNSBORO TOWNSHIP

WHEREAS, West Pennsboro Township requires that permits shall be required by all transient retail business within the Township of West Pennsboro Township subject to fees to be set from time to time by Resolution of the Board of Supervisors; and


WHEREAS, the Board of Supervisors of West Pennsboro township wish to adopt and insert a current fee schedule for such licenses and application fees as set forth in the 2011 Fee Schedule adopted by the West Pennsboro Township Board of Supervisors.

NOW THEREFORE, be it resolved by the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania that fees listed on "Exhibit A" that is attached to this Resolution, shall be applicable to obtain a license pursuant to Ordinance #2010-04, for engaging in transient retail business within West Pennsboro Township.


